History

- 2019 CMHA Muskoka Parry Sound had been awarded RAAM funding
- WPSHC/NLPC Team Leads met with CMHA and formed a partnership to deliver the medical care through the RAAM partnership under the umbrella of the WPSHC/hospital
- RAAM launched in May 2019 2 days per week (Mondays and Thursdays), out of the WPSHC Ambulatory Care
- AMCT (Addiction Medicine Consult Team)- bridged primary care, ED, hospitalist, ICU, other community consultation.
- Addressing Covid Barriers
- Safe transitional bed support- In patient withdrawal support, education, consultation.
- DSAAB/Hospice Partnership


POLICY BACKGROUND

Crystal Gracie was an Anisinaabe kwe (Ojibway Women) and Registered Band Member of Shawanaga First Nation, Ontario Canada. At the age of 27, Crystal was diagnosed with hereditary angio-edema type 3 and subsequently, sarcoidosis. Crystal experienced ongoing complicated flareups of widespread body pain and swelling, along with repeated episodes of life-threatening airway compromise. Crystal self-identified as Indigenous First Nation when accessing the healthcare system in Ontario. Crystal faced multi-leveled stigma and racism at various points of healthcare access and delivery. It is noted that Crystal also received excellent care. Unfortunately, Crystal went on to the Spirit World (passed away), March 25, 2022, at the age of 31. Connie Foster, her mother, advocate, and nurse practitioner at the West Parry Sound Health Centre/Rural Nurse Practitioner Led Clinic, spear-headed the idea to enact an anti-stigma anti-racism policy with First Nation engagement and support, in collaboration with a local working group in north Muskoka and Parry Sound, Ontario. This policy stands to ensure that there is a formal process set in place of the expected code of conduct that all healthcare services delivered and accessed under the umbrella of the West Parry Sound Health Centre are free from stigma and racism. The policy accompanies a reporting process and steps set in place to address reports of stigma and racism with the foundation of the policy rooted in education. This accountability and responsibility are across the entire organization and is implemented to ensure that the understanding of the policy and expected code of conduct is Crystal Clear. The Leadership of the West Parry Sound Health Centre have agreed to be the first to implement the first Crystal Clear Code of Conduct policy.




